## HEALTH INSURANCE

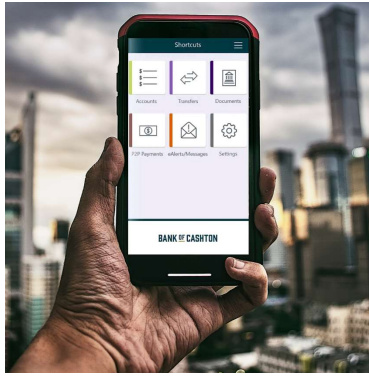
