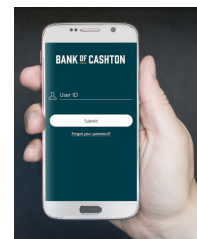

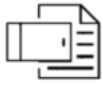
BILL PAY SOLUTIONS

We will NEVER:

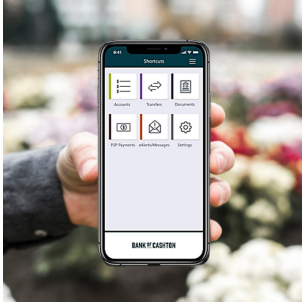
- Ask you for your PIN number
